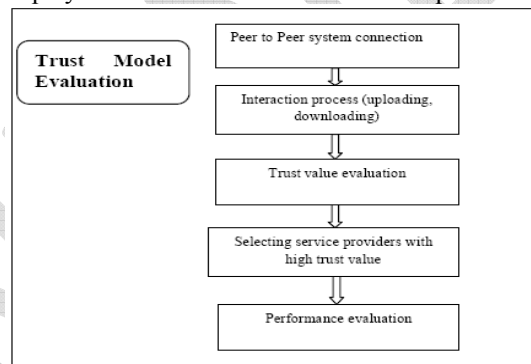


Fig 1 Architecture flow of the process
