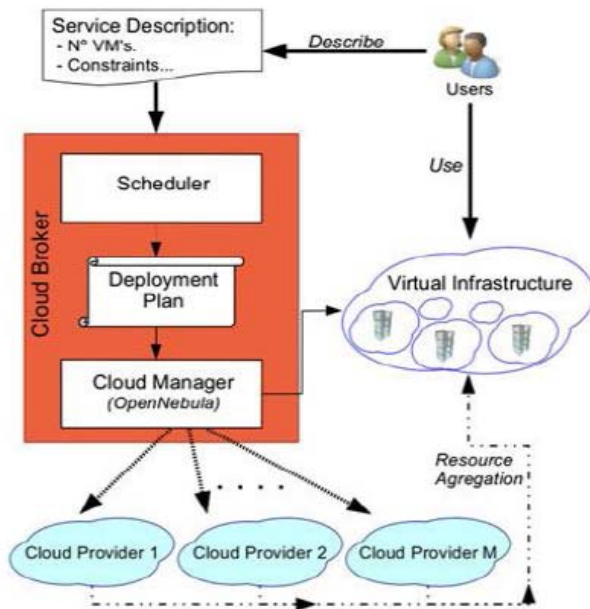


FIGURE 1: Cloud brokering architecture overview [10]
